This Bull had an ADG on a Silage and grain ration, of 2.35kg/day over 79 days from the 2/8 to the 20/10, and has gone onto a silage maintenance ration since. The Mayo Team place a strong emphasis on predominantly average daily gains, and marbling score genetics when sourcing sire lines to introduce into their operation.
