BRED FROM LARGE FRAMED GLENWOOD BLOOD MERINO SRS EWES AND ARE SIRED BY TOP END GLENWOOD AUCTION RAMS. PLEASE NOTE. APROX 3 LONG TAIL LAMBS OBSERVED HOWEVER MARKED AT ASSESSMENT, A SMALL PORTION OF LAMBS WERE NOTED TO HAVE EAIRLY SIGNS OF PINK EYE OF GRASS SEED IN EYE AND WERE TREATED WITH EYE OINTMENT AT ASSESSMENT.
