They are out of large framed cows, & possess the breeding potential to develop into heavy future breeders, whilst also maintaining the carcass shape & early maturity required to finish into Trade markets as yearlings for a fattening operation. These heifers would normally be grown out & retained by the vendor as replacement breeders however, due to continued dry weather, & feed quality diminishing, the decision has been made not to hold any replacements this year. Attractive, quiet cattle that would grow out into lovely quiet future breeders given the opportunity.
