A separate mob to other ewes in sale and have been kept that way till delivery. Please note there are a small percentage of ewes with white tags, these were used as replacement tags. Ewes starting to even wear in the mouth, normal for the country they run on with plenty of life in them, please see photos. Sheep also had 3-4mm of rain on them in light rain before and during assessment.
