They will be sold as a run out the gate of two lots of 415. North Cowie bloodline has been used for past 34 years and the flock can be described as med to large frame, growing plenty of quality medium micron wool. Please note odd ewe showing light ewe horn or scour typical of pure merino genetics. Grow these out as future breeders to join later in the spring then class up when they are in lamb. Alternatively they would be great ewe lambs to tuck away and polish up to sell in the spring, or maybe even fatten for a winter kill.
