They are out of large framed cows, & possess the breeding potential to develop into heavy future breeders, whilst also maintaining the carcass shape & early maturity required to finish into Trade markets as yearlings for a fattening operation. These heifers would normally be grown out & retained by the vendor as replacement breeders however, cow numbers are currently at capacity.
