Approximately 15% of the Heifers appear to be sired by Lancaster SimAngus Bulls (3/4Angus1/4Sim) and show slight European characteristics. Heifers display adequate frame despite a young weaning age and are not carrying any excess condition and will do extremely well given the right opportunity, with previous calves reaching feeder and export weights with ease.
