Heifers present in predominately store condition with plenty of bone & length. Cattle were mustered the day prior to assessment had a big curfew before being weighed and would expect buyer to see plenty of compensatory gain. This line would suit both feeding on to heavier weights or future breeding with vendor being very selective in genetics. At assessment 2 x heifers noticed with small warts near eye, 2 x heifers with double muscling 1 x heifer with small lump on jaw.
