The lambs have been grain trained as each ewe lamb outfit has been supplemented approximately 1kg of barley 3 times per week the lambs are still on their mothers which are still milking quite well as such a conservative weight gain of 100grams per head per day is added to the assessment. Please note there is 4 lots of lambs from the same vendor totaling over 1000 head. Please not a small percentage of this line were observed to have scabby mouth less than 10% at assessment.
