All ewes have raised a lamb in a prior joining and most have raised two. They are August shorn cutting approximately 7.5 kg of wool and have been drenched in august with Q-Drench. They present in forward condition with some ewes in plainer condition being the ones who have a large weaner lamb still on them.
