All were individually weighed 35kg+ full to range from 35-53kg (ave. 39kg) at assessment. These ewes will go on to produce very heavy export lambs with the 2023 drop older brothes averaging 34kg cwt off crop (see video). They have received a full health treatment and are ready to be grown out to become excellent breeders for many years to come. Please note; vendor is also offering 335 wether lambs in this sale for a total of 805 lambs being offered. Ewes are located at two properties approx 30km apart with media of both lots.
