These June/July 2023 drop classed out ewes are doing well since shearing and present in strong store to forward condition. They are NSM. You will notice they havent had a drench besides the weanerguard, this is due to very low Fecal Egg Counts(FEC) throughout the year. Can highly recommend these ewes. NOTE- These ewes were reweighed 16/12/24 and weights entered in this assessment. Av 55.3kg. Ewes will be given a EweGuard prior to delivery
