| Assessor Comments                     | Buyers these cows & calves are ideal units to fatten & split. The breeders are EU Accredited as are the calves and the calves are also PCAS Eligible. These cows are sound in the legs, eyes, hips, however there are 12 cows with bottled teats in either 1 to 3 teats. They are doing a good job on this calf however I don't recommend these 12 cows as continuing on as breeders, the other 29 cows would be suitable to join again. Note there is a cow with a small lump on her jaw, and a cow with an old proud scar on her rib cage. There are 2 calves with enlarged navels possibly from the wet weather- they don't look like ruptures. On a whole these are large framed breeders that will fatten into good heavy cows, and these calves will grow into very good supermarket feeders, or PCAS kill cattle.
