They must be highly fertile, conceiving at 6 to 8 months of age and successfully rearing lambs, to remain in the flock. They are selected for positive genetic muscle and fat – these body reserves are 'doing ability' which reduces feed costs, improves survival, adds to carcass value and increases marketing options. They are worm resistant and resilient and can survive and produce in high rainfall zones, with just one or two drenches a year.
