All heifers were mouthed at assessment (3 - milk tooth, 7 - two tooth, and 1 - four tooth). The majority of the milk-tooth heifers are close to breaking into twos. Would suit to calve down and grow heifers onto a kill carcass weight or potentially use as future breeders. NOTE: All heifers were treated for buffalo fly at assessment.
