Generally the cattle were good to handle. Vendor has made concerted effort to manage cattle calmly through weaning and health treatments, particularly through using De-Stress in water source. Most steers handled assessment well with approx 2 head showing stirriness in tight confines of weigh cradle. Have at times in the past displayed some run when moving yard to yard but previous purchasers have suggested steers settle well. However, during photographing of steers they looked very relaxed.
