Seasonal conditions coming into winter see's a regrettable sale of these future breeders, heifers are on the lighter of where they should be but given he right conditions after calving they will continue to grow into large frame female consistent with Javor herd as I don't believe they have been checked through their growing stages, Heifers had great conception rates showing great fertility. The valve is in the genetics of these heifers, only two weeks ago the Javor steer weaners topped the A + market making 485 cents at 319 kg. Calving July onwards to LBW bulls
