Angus cows are from a very productive Rennylea blood herd with bull selection also on marbling, muscling and growth. These heifers are in good healthy condition given what has been an exceptionally tough season in the Corryong/Tooma region. They have been extensively supplementary fed and they present in forward store condition. This line of cattle would ideally suit a backgrounding operation and previous purchasers have been very happy with their performance. Full bull pedigrees are attached in "Documents" section. Door Key, Sunnyside and Trent Bridge bloodlines. NOTE - THIS OFFERING IS WITHIN AN ESI.
