Assessor Comments	A line Angus Heifers that are well and truly just about to start to hit their straps. An incredible harsh last 10-12 months this area has had. Due to this, we have probably seen the livestock struggle to do the minimum, therefore the operation have had to start feeding by containment with a crushed grain mix from Farmgate stockfeeds plus barley straw. There is probably a spread of 6 months of age over the line. Calves present in forward store condition and are starting to freshen up. There is the odd Heifer with a pink eye scarring or shadow, deemed not detrimental in my opinion.
