With medium to large frames the heifers suit to take directly onto feed for the domestic supermarket trade or grass and crop finish. They also suit to join with the top 50% as very good future breeders. They had a LWR of 301kg to 446kg which was classed as a full weight eventhough they were mustered off oats at 5pm the evening before and then held in a good grass/clover paddock overnight. The vendor bred heifers were bred on the family's property north of Dalby and non vendor bred heifers purchased as calves at foot. They are 100% LT. They have been rotated through good quality improved pastures and now on oats for the last 12 weeks. They have not had access to any bulls and were vet preg tested at assessment as 100% NDP. They are mostly Angus x Angus heifers with the Angus cross heifers showing either some white on the underline or a little navel.
