Yards were very wet with plenty of strangers present when assessed and the vendor mentioned it was out of character to their normal behaviour. Yard design is also not conducive to handling cattle in a quiet manner. Broken in and hand fed with hay from a buggy so easy to handle in the paddock. Odd one could become aggressive if isolated.
