These are good quality Angus heifers bred from females purchased out of the New England area that present in mainly store condition. The heifers are very quiet; the vendor's always do an excellent job throughout the weaning process and this is reflected. Heifers bred on lighter country, and I will suggest they will fly ahead if they get access to better feed conditions especially on heavier country. There has been plenty of rain north of the border regions that have completely missed out and would be an opportunity to fill paddocks. All the hard work is done; well and truly over the weaning process. Ideal to put away and background to heavier weights & meet all domestic feeder specs later in the year. Wongavale cattle are continually attracting repeat buyers, evidence they must perform. There are 37 steers available from the same property to fill decks.
