Heifers were pregnancy tested on day of assessment with 92% tested non detectable. 15 head out of the entire run of 188 were injected with Juramate Prostaglandin on the 27/7/26. Three heifers have old pink eye scaring in an eye but doesn't appear to be affecting their sight in any way. Three heifers have a little white on their udder. There are another 94 heifers in the same sale which will be delivered as a run out the gate and every effort will be made to deliver even lots in the event of multiple buyers.
