This line of lambs represents the second draft of the drop, with the lead sent to the trade and the remaining lambs offered in the same sale. They present even as a group and in slightly forward condition. These suckers are proven performers amongst previous purchasers and are bred from large frame ewes.1305 suckers offered in this weight range in 3 lots of 435 and will be delivered of equal quality via drafting gate.
