Averaging 57.8Kg and topping at 65Kg at assessment, these ewes have continued to power ahead during the warmer and wet months we have experienced. These ewes were purchased as NSM Eriwah bred ewes from the 2021 Hay ewe sale. Ewes were joined for 6 weeks and are due to commence lambing at the end of February. Ewes are mulesed and average 1.5 inches of wool length, October shorn. Ewes have been drenched, vaccinated and dipped. Clean open faced sheep bound to produce desirable 1X breeding female progeny and trade or export market male progeny. A great opportunity to secure a line of one mark, riverina bred merino ewe hoggets, 121% SIL to Border Leicester Rams.
